

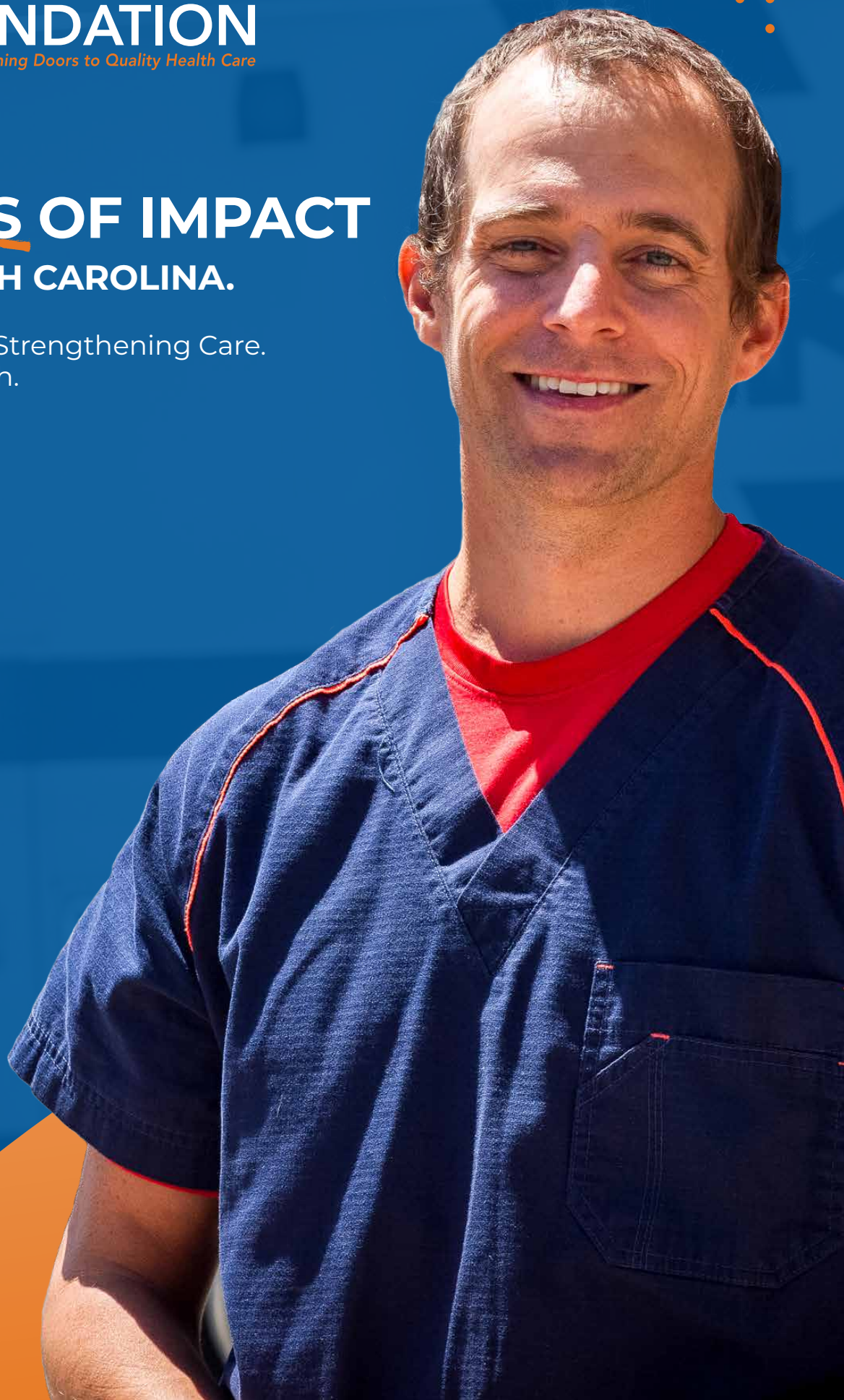

OUR STORY.

As I sit down to write this letter, I'm amazed that the NCMS Foundation is celebrating its 60th anniversary! What started as a vision in 1966 has grown into an innovative health care powerhouse across our state. Though the impact of the Foundation has outlived its founders, I wish these visionaries could see a glimpse of what they were creating 60 years ago.

Founded in 1966, the NC Medical Society Foundation was created to complement the work of the North Carolina Medical Society, bringing a long-term, philanthropic focus to the challenges facing health care across the state. While the NC Medical Society has focused on advocacy and support for physician and PA practices, the Foundation has worked to address broader, systemic needs. Over time, this has included building endowed funds for educational loan repayment, developing programs to support future health care leaders, and fostering partnerships across North Carolina's health ecosystem.

As new challenges have emerged, the Foundation has continued to evolve—serving as an incubator for innovative programs that respond directly to gaps in care, workforce needs, and community health. Now, 60 years later, that role is more important than ever.

As the husband of a physician, I've witnessed the challenges of North Carolina's health care system for decades. This front-row seat has helped me appreciate the work of the Foundation even more—**work that is only possible because of sustainers like you.**

Thank you for believing that health and well-being should be within reach for every North Carolinian. In the pages that follow, you'll learn about our range of programs and their impact—programs that reflect decades of investment in strengthening the health care workforce, expanding access to care, and responding to the evolving needs of our state. OUR WORK.

Access to quality health care is essential to the well-being of every community, but across North Carolina, that access remains out of reach for many.

Rural areas across the state continue to experience persistent physician shortages, leaving patients with limited options for care close to home. Health disparities, including the rising cost of care, compound these challenges, affecting outcomes for vulnerable populations and creating gaps in access that impact entire communities.

At the same time, clinicians face mounting pressures. Administrative complexity, workforce shortages, and increasing demand contribute to burnout and make it more difficult to recruit and retain providers in high-need areas.

The result is a system under strain, in which patients may delay care, travel long distances for treatment, or forgo care altogether.

Without intentional investment and targeted solutions, these challenges will continue to grow.

This is where the NC Medical Society Foundation steps in as a **trusted partner in improving access to quality health care across our state**. For decades, we have worked alongside physicians, clinicians, and communities to strengthen the systems that deliver care, especially in rural and underserved areas where the need is greatest.



MISSION

To improve access to quality health care for all North Carolinians.

BELIEF

We believe health and well-being should be within reach for every North Carolinian. By supporting physicians and their health care teams through loan repayment, education, leadership, and innovation, we expand access to quality health care, strengthen communities, and advance health equity across our state.

- + **Health Equity:** Address disparities and expand equitable access to quality health care across all communities.
- + **Access to Care:** Support initiatives that improve access to care and strengthen the health care workforce across North Carolina.
- + **Community Health:** Strengthen partnerships with public health, community organizations, and other sectors to improve health at the community level.
- + **Collaboration:** Promote teamwork across physicians, health care teams, and community partners to improve care and health outcomes.
- + **Leadership:** Invest in education and leadership development that supports physicians and their health care teams.

OUR PROGRAMS.



Guided by a commitment to access, equity, and innovation, our work focuses on building stronger systems of care, supporting the health care workforce, and creating lasting improvements in health outcomes statewide.

The NCMS Foundation currently supports **10 programs** that address critical needs across North Carolina's health care system. These programs are reducing health disparities, expanding access to care, and strengthening the future of medicine through education, leadership development, and workforce support.

COMMUNITY PRACTITIONER PROGRAM (CPP LEGACY)

The Community Practitioner Program supports clinicians serving in rural and underserved communities through educational loan repayment and professional development. By reducing financial barriers and strengthening retention, the program helps ensure that providers can build lasting careers where access to care is most limited.

COMMUNITY PRACTITIONER PROGRAM 2.0 (CPP 2.0)

CPP 2.0 builds on the success of the original program with a focus on long-term workforce sustainability. By supporting recruitment, retention, and community integration, the program helps create stable care environments and improve access to consistent, high-quality care.

ACADEMY FOR HEALTHCARE LEADERS

Formerly the Kanof Institute for Physician Leadership, the Academy for Healthcare Leaders prepares clinicians and health care professionals to lead in a rapidly evolving environment. Offered through Future, Advanced, and Executive tracks, the program provides education and training that strengthen leadership skills across every career stage and support better decision-making and improved care delivery.

NC CLINICIANS AND PHYSICIANS RETENTION AND WELL-BEING CONSORTIUM (NCCPRW)

The NCCPRW brings together partners across North Carolina to address clinician burnout and improve retention. Through collaboration and targeted strategies, the program supports a more sustainable workforce and helps create environments where clinicians can continue to lead and serve effectively.

ONSMS REAL TALK PARTNERSHIP

Through its partnership with the Old North State Medical Society, the Foundation supports suicide prevention workshops that promote clinician well-being and reduce stigma around seeking help. Programs like Real Talk: Navigating Life's Hard Moments Together serve as a leading example, offering evidence-based training that equips clinicians and communities to recognize warning signs, engage in meaningful conversations, and connect individuals to appropriate support.

PREFERRED VENDOR PROGRAMS

Preferred Vendor Programs create strategic collaborations that provide physicians and practices with access to essential tools, resources, and services. These partnerships support practice sustainability, improve operational efficiency, and enable providers to focus on delivering high-quality patient care.



TRANSFORMATION RESOURCE FOR ACCOUNTABLE CARE (TRAC)

TRAC is a centralized hub for tools, learning, and collaboration that supports system-wide transformation across the health care ecosystem. By translating complex concepts into practical guidance, TRAC provides resources, technical assistance, and shared learning opportunities—helping clinicians and organizations advance value-based care and deliver better, more coordinated, and more equitable outcomes.

NC PROFESSIONALS HEALTH PROGRAM (NCPHP)

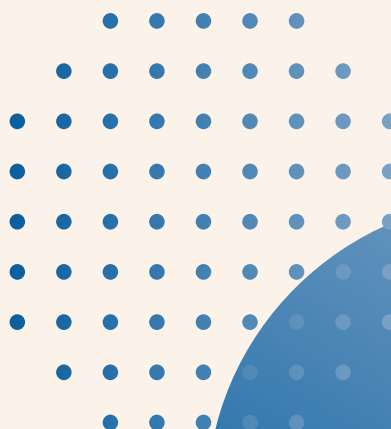
The NC Professionals Health Program provides confidential support and resources to help clinicians manage personal and professional challenges. By promoting well-being and recovery, the program plays a vital role in sustaining the health care workforce and protecting patient care.

PROJECT VIRTUAL OPIOID TREATMENT (VBOT)

Project VBOT expands access to treatment for opioid use disorder through innovative, virtual care delivery. By reaching patients in communities with limited resources, the program helps address a critical public health need and increases access to life-saving care across North Carolina.

DISASTER RELIEF & FINANCIAL RECOVERY PROGRAMS

The Foundation provides critical funding and rapid-response support to health care practices impacted by natural disasters and economic disruption. These efforts help stabilize clinics, maintain access to care, and ensure that communities continue to receive essential health services during times of crisis.
